Non-Immigrant 'B' Visa (Employment)

The Non-Immigrant "B" Visa has 2 categories: SINGLE ENTRY and MULTIPLE ENTRIES.

SINGLE ENTRY

Purpose of Visit: If the purpose of your visit is to teach or work, you may apply for the Non-Immigrant "B" Visa before entering Thailand.

Validity of a Visa: The validity of a visa is 3 months.

Period of Stay: Travelers will be permitted to stay in Thailand for a period of not exceeding 90 days.

Visa Processing Fee: \$120.00 AUD per application.

Documents Required:

- Your actual Passport or Travel Document. (Passport or Travel Document must not expire within 6 months and contain at least ONE completely empty visa page);
- A copy of the biographic page of your passport or travel document;
- A completed and signed application Form A;
- One passport-size photograph (3.5 x 4.5 cm.) taken within 6 months with a full-face view without hat or glasses. (Photocopy not accepted);
- Letter of acceptance from your employer in Thailand
- Copy of your work contract / Valid work permit;
- A copy of your employer's business registration or license in Thailand;
- Copy of updated bank statement providing of adequate finances (THB 20,000 per person, THB 40,000 per family, THB 200,000 for multiple entries)
- Copy of an airline ticket indicating the date of arrival to and departure from Thailand or letter stating the itinerary/ travel plan of the applicant.
- If you are not an Australian citizen, a proof of Australia Permanent Residency Visa(VEVO) is required.

Additional documents required for TEACHER IN PRIVATE SCHOOL - Single Entry Only

- A letter of approval from Thai government agencies such as the Office of the Private Education Commission of the Office of the Basic Education Commission.
- Both applicant's resume and a copy of educational qualification such as certificate of education or teaching certificates.

MULTIPLE ENTRIES

Purpose of Visit: This type of visa is issued to applicants, who wish to teach and work in Thailand.

Validity of a Visa: The validity of a visa is 12 months.

Period of Stay: Travelers will be permitted to stay in Thailand for a period of not exceeding 90 days for each visit unless he or she has a valid working permit in Thailand.

Visa Processing Fee: \$300.00 AUD per application

IMPORTANT- AS OF 15 AUGUST 2016, THERE ARE STRICT REQUIREMENTS REGARDING THE ISSUANCE OF MULTIPLE ENTRY NON -IMMIGRANT VISAS, WHICH WILL ONLY BE ISSUED ON A CASE BY CASE BASIS. FOR FURTHER INFORMATION, PLEASE CONTACT US DIRECT TO DISCUSS ANY SUCH APPLICATION.

Payment Method: Fees are to be paid in Australian Dollars and made out to 'Royal Thai Consulate-General, Brisbane' by the following methods:

- a) **Cash (Australian Dollar ONLY)**
- b) **Money order (from Australia Post) payable to Royal Thai Consulate-General, Brisbane**

*Personal and company cheques **WILL NOT** be accepted.*

Visa Processing Time: All visas will take a minimum of 2 working days to process once a completed application has been received.

Apply by Mail: All applications sent via mail must include all the requirements and payment, made out to 'Royal Thai Consulate-General, Brisbane' and sent to the Postal Address below.

Important: Visa applications will only be accepted if they are sent via registered post and will only be returned if they include a self-addressed registered envelope, or express post with signature on delivery.



Registered Post will be accepted



Express Post will be accepted **ONLY with signature on delivery.**
