

The Royal Thai Consulate-General, Brisbane

Non-Immigrant 'O' Visa (Spouse/Partner/Family)

Purpose of Visit: This type of visa is issued to applicants who wish to visit their Thai family.

There are 2 categories of a Non-Immigrant "O" Visa: SINGLE ENTRY and MULTIPLE ENTRIES.

SINGLE ENTRY

Validity of a Visa: The validity of a visa is 3 months.

Period of Stay: Travelers will be permitted to stay in Thailand for a period of not exceeding 90 days unless he or she has a residence permit.

Visa Processing Fee: \$120.00 AUD per application

Documents Required:

- Your actual Passport or Travel Document. (Passport or Travel Document must not expire within 6 months and contain at least ONE completely empty visa page);
- A copy of the biographic page of your passport or travel document;
- A completed and signed application Form A;
- One passport-size photograph (3.5 x 4.5 cm.) taken within 6 months with a full-face view without hat or glasses. (Photocopy not accepted);
- If you are a former Thai citizen, proof of Thai citizenship such as Thai passport or Thai I.D. card;
- If you want to visit as a spouse or family member (son or daughter) of Thai citizen, a proof of relationship such as marriage certificate or birth certificate is required;
- Copy of the visa or work permit of a spouse or parent who is currently working in Thailand (If your partner or Family member are not Thai citizen)
- A letter from your spouse or family member verifying the current status of relationship together with their Thai I.D. card. and house registration;
- A copy of airline ticket confirming the date of your arrival to Thailand as well as your departure from the country;
- If you are not an Australian citizen, a proof of Australia Permanent Residency Visa (VEVO) is required.

MULTIPLE ENTRIES

Validity of a Visa: The validity of a visa is 12 months.

Period of Stay: Travelers will be permitted to stay in Thailand for a period of not exceeding 90 days unless he or she has a residence permit.

Visa Processing Fee: \$300.00 AUD per application

IMPORTANT- AS OF 15 AUGUST 2016, THERE ARE STRICT REQUIREMENTS REGARDING THE ISSUANCE OF MULTIPLE ENTRY NON -IMMIGRANT VISAS, WHICH WILL ONLY BE ISSUED ON A CASE BY CASE BASIS. FOR FURTHER INFORMATION, PLEASE CONTACT US DIRECT TO DISCUSS ANY SUCH APPLICATION.

Disclaimer: Consular officers reserve the right to request additional documents as deemed necessary as well as reject any application without having to provide reason.

Payment Method: Fees are to be paid in Australian Dollars and made out to 'Royal Thai Consulate-General, Brisbane' by the following methods:

a) **Cash (Australian Dollar ONLY)**

b) **Money order (from Australia Post) payable to Royal Thai Consulate-General, Brisbane**

*Personal and company cheques **WILL NOT** be accepted.*

Visa Processing Time: All visas will take a minimum of 2 working days to process once a completed application has been received.

Apply by Mail: All applications sent via mail must include all the requirements and payment, made out to 'Royal Thai Consulate-General, Brisbane' and sent to the Postal Address below.

Express Post will be accepted **ONLY with signature on delivery.**
