### NON-Business Visa

#### Single Entry

- Passport with a minimum validity of no less than 6 months prior to departure and its copy
- Visa application form, fully completed
- Recent passport-sized photograph (3.5 x 4.5 cm) of the applicant
- Australian Electronic Visa (VEVO) for proof of residence in Australia (only for Non-Australian passport holder)
- Permission to travel from Australia issued by the Australian Border Force <https://immi.homeaffairs.gov.au/help-support/departmental-forms/online-forms/covid19-enquiry-form> (For Australian national/citizen or permanent resident).
- Proof of residential address in Australia
- Confirmed accommodation under the applicant's name for the duration of intended stay in Thailand, (after 14-day stay at Alternative State Quarantine (ASQ) upon entry into Thailand).
- Proof of adequate finance - copy of updated bank statement with **a minimum balance of THB 500,000 or AUD 25,000 maintaining in bank account in the last 6 months**
- For doing business:
  - Invitation letter from the host company/organization in Thailand indicating the date and length of stay, and purpose of visit; **and**
  - Evidence of registered capital of the host company/organisation with a minimum amount of THB 2 million
- For investing in Thailand:
  - Evidence of ownership of condominium in Thailand; or
  - Evidence of money transfer and Thai bank account / Thai Government bond with a minimum amount of THB 3 million
- Visa processing fee – AUD 120

#### REMARK:

- Applicants are required to pay a visa fee which is non-refundable, regardless of whether the visa is approved or rejected.
- The Royal Thai Embassy in Canberra reserves the right to request additional documents as deemed necessary as well as reject any application without prejudice.
- The applicants must provide genuine documents and information. If the applicants are found to provide false documents or give false information, their applications will be rejected and be reported for further determination of appropriate action and future prohibition to enter the Kingdom of Thailand.
- All visa fees can be paid by exact amount of cash, money order, to Royal Thai Consulate, Brisbane (personal/company cheque are not acceptable)
